Transfer of Franchise Ordinance dated September 4, 2011 (the "*Franchise*"), granted by Alamance County (the "*County*") to Coble's Sandrock, Inc., 5833 Foster Store Road, Liberty, NC 27298 ("*Coble's*") pertaining to the operation of a construction and demolition debris landfill located at 5833 Foster Store Road, Liberty, NC 27298 ("*Landfill*") in accordance with Facility Permit No. 0105-CDLF-1998 issued by the State of North Carolina Department of Environmental Quality, Division of Waste Management, Solid Waste Section (the "*Permit*")

Dear Ms. York:

As you are aware, Coble's has been in discussions with Meridian Waste North Carolina, LLC ("Meridian") regarding the sale of its business, including the operation of the above captioned Landfill in accordance with the Franchise and the Permit. The terms of the Franchise dictate that a transfer of the equity in Coble's currently owned by Kent and Brenda Coble (other than to certain of their family members designated expressly in the Franchise) requires approval from the County.

Accordingly, on behalf of Coble's, we hereby request that the County grant its consent to the sale by Brenda and Kent Coble of 100% of their equity in each of Coble's and Coble's, L.L.C. to Meridian, with the understanding that Meridian will continue to operate the Landfill in accordance with the Franchise and the Permit (the "*Proposed Sale*"). We believe that Coble's has previously evidenced Meridian's experience and credibility and that Meridian is capable of continuing to operate the Landfill in accordance with the Franchise and the Permit. The County has previously taken action to approve Meridian as a qualified Franchise. Accordingly, we hope that the Proposed Sale can be discussed, and approval thereof granted, at the next regularly scheduled meeting of the County's commissioners.
