#### **ISSUE/ACTION REQUESTED:**

The Board will consider amending the General Fund to increase by \$77,218 and the Emergency Telephone System Fund by \$16,345.

# BACKGROUND/PURPOSE OF REQUEST: General Fund

#### 1. Health

The Health Department received notification of award of \$60,873 from the North Carolina Division of Public Health / Environmental Health Section / Food Protections and Facilities Branch for additional Aid to County funding (Agreement Addendum [AA] 874) The Agreement Addendum allows for the Local Health Department's environmental health program to implement state-mandated sanitation regulations. The funds from this Agreement Addendum are to be used to support local Food and Lodging programs and activities. No County match is required.

#### **County Renovation & Repair Fund**

#### 2. Facilities Management

The Facilities Management Department requests to transfer \$26 in project savings from the purchase of the New Board of Elections building to the 108-A S. Maple Street building purchase for the cost of property taxes owed on the Maple Street purchase in the County Renovations and Repair Fund. This amendment will not add appropriation to the County Renovations and Repair Fund.
